

## T1 - VESSEL TAX (PORT DUES)

(Title VII - Chapter II - Section 4 - Subsection 1 of the Royal Legislative Decree 2/2011)

1.- The taxable activity is the using of port waters and service areas by vessels.

2.- The taxable persons are the ship's owner and the master.

Should the vessel have an agent, this ship's agent will be considered the substitutive taxable person.

3.- The tax is due when the vessel enters waters on the APB service area.

4.- The gross tax payable is calculated as the product of the basic amount "B" or "S" (1,43 € or 1,20 € from 2014), the correcting coefficient of T-1 tax (to be 1,00 as set by APB for 2023) and the applicable coefficients as per below chart:
